

WCS AWWA Chair Report

The year 2016 has been a period of strategic planning for both AWWA and the WCS AWWA. AWWA released its updated Strategic Plan at ACE16 this past June, and the WCS AWWA Strategic Plan 2017-2020 was finalized in August in time for release at the WCW Annual Conference and the Section's AGM in Calgary this October. I'm confident that both strategic plans will guide our Board, Committees and Programs on a successful path, and one which provides increasing levels of benefit to our members.

A noteworthy AWWA initiative that is supporting our future industry talent is the 'Fresh Ideas Poster Competition'. This annual competition is aimed at student and young professional (YP) members, showcasing their work and talent with an opportunity to compete at an international level at AWWA's Annual Conference and Exhibition (ACE). The winner from the 2016 section competition held at the WCW Conference in Calgary will go on to represent our Section at ACE 2017, in Philadelphia, PA. I encourage all student and YP members to participate in this annual event, and all members, mentors and supervisors of eligible competitors to support this poster competition at our annual conferences.

Our Cross Connection Control (CCC) Committee is undertaking an extensive make-over of the reference manual, which is widely used by CCC trainers as the 'AWWA Canadian CCC Manual'. The new look manual will feature improvements to the presentation of information and graphics, as well as new content that will enhance its impact in training programs across Canada. If the utility you work with doesn't currently have a CCC program, or is looking to update staff skills and certification, visit our website www.wcsawwa.net under Backflow Prevention to find out more and for a list of trainers across our region.

As part of our volunteer leadership development program our Section's Board and Committee leadership are provided with opportunities to attend workshops and summits through AWWA on topics such as Young Professionals, Education, as well as Membership Engagement and Development. This year's volunteer training opportunities were well attended, however we are always looking to expand our future leadership resources and provide interested individuals with the development and training they will require to contribute to our association and industry. If you are interested in exploring opportunities with WCS AWWA or AWWA, please do not hesitate to contact a Board Member, Committee Chair or our Executive Director through the WCW Office.

This past year was also a busy social time for many of our members, with great industry networking events being held across our territory. The efforts of volunteers and staff to host these valued events are tremendous, reflecting a culture of collaboration, which is core to our industry. Water for People Committee volunteers held curling bonspiels in Calgary, Regina and Winnipeg during the cooler months and the popularity of these events is a testament to the organizers and participants. The Young Professional Committee and city representatives have also been busy providing interesting venues and concepts for networking opportunities, including plant tours in Saskatoon and Calgary, a tour of the Canadian Museum of Human Rights in Winnipeg, as well as bowling nights and beverage tastings in Winnipeg and Regina.

Our Section's volunteer base also provide invaluable resources to provide and promote continuing education and training opportunities to our membership and industry partners, through the participation in the Provincial Council coordinated seminar and training programs, as well as AWWA specific training events.
