

PROVINCIAL TRUSTEE

The Trustees are elected positions and take part in all actions of the Board. Each trustee will have voting power within the Board.

DUTIES

- 1. Attend all Section Board meetings.
- 2. Serve as Board liaison to committees as assigned and ensure that the committees work towards the strategic initiatives of the Section. Be familiar with Section bylaws and AWWA Governing Documents.
- 3. Perform such duties as may be assigned by Chair.
- 4. Participate with all Board members in promoting the value of AWWA membership.
- 5. Participate in Provincial Council meetings and promote PC efforts in province of residence.
- 6. Coordinate Networking Events in respective province.
- 7. Assist with coordination and delivery of education events in respective province.

MEETINGS

- 8. All Section Board meetings.
- 9. Western Canada Section AWWA annual conference held in conjunction with the WCW annual conference.
- 10. Committee meetings, where possible, as Board Liaison.
- 11. Provincial Council meetings in province of residence.
- 12. Regional Meeting of Section Officers (RMSO) when possible.
- 13. Annual AWWA Conference and Exhibition (ACE) and relevant meetings at the ACE, when possible.

TERM OF APPOINTMENT

14. The term shall be three years unless otherwise approved by the Board.
